

## Overview:

•

As part of the Financial Systems Transformation (FST) Program, in conjunction with the implementation of the Oracle Cloud ERP suite, an analysis of campus shadow systems kicked off in March 2022, to identify which systems would require retrofitting and which would be replaced. In this analysis, the University reviewed a list of 139 ancillary systems currently used across campus that impact financial and financial reporting operations, and any systems identified as "non-financial" were noted as out of scope for this project.

## Key Terms/Definitions:

- Retain Retrofits Required Retaining of an existing software solution, with modifications to ensure integration with Oracle Cloud ERP
- Retain No Retrofits Required Retaining of an existing software solution, determined no modifications necessary
- Sunset/Replace Systems identified as no longer necessary as their functionality will be consolidated by one of the following 4 main categories: • Oracle Budgeting & Planning - Go-Live on 2/16/24
  - Oracle Cloud ERP– Go-Live on 7/1/24
  - Third-Party system a replacement system outside of Oracle Cloud
  - Orbit Datawarehouse and reporting
  - Peripheral Application An application indirectly impacted by the implementation of Oracle Cloud ERP/will not integrate with Oracle

If you do not see an application used by your unit on this list, it is likely either an indirectly impacted system OR out of scope.
